Fill out this registration form to ride a Permanent route for any route during the year. Online pre-registration and payment is required for each route. Please give reasonable notice. Every effort will be made to accommodate your ride on the date you request. However, the organizer reserves the right to decline any entry, on any date, without stating a reason. Membership of Randonneurs USA is mandatory to ride a Permanent route. The release form (bottom half of page) must be signed also (for RUSA's insurance policy). There are no refunds.

APPLICATION

I agree that this Release applies to each and every permanent ride for which I register during the period January 1, 2016 - December 31, 2016 that is listed at the time of registration on the Salt Lake Randonneurs or Rando Richard websites (hereafter, a "Permanent") and to each and every instance of my participation in a Permanent commenced during the such period, regardless of whether or not I execute a separate Accident Waiver and Release of Liability at the time I register for each individual Permanent, and regardless of when I execute this Release.

If I do execute a separate form of Accident Waiver and Release of Liability at the time of registration for any Permanent, the terms and conditions of this Release shall remain in full force and effect, but may be supplemented or expanded by the separate form of Accident Waiver and Release of Liability. Further, for the avoidance of doubt, I agree that a separate form of Accident Waiver and Release executed or confirmed by me by electronic or digital means at the time of registration for an individual Permanent that has terms and conditions substantially similar to the terms and conditions of this Release shall be binding and apply to the Permanent in the same manner as if I had physically signed the form.

ACCIDENT WAIVER AND RELEASE OF LIABILITY (PRIVATE)

In consideration of being permitted to participate in any way in the Permanents (Activities or Activity) I, for myself, my representatives, assigns, successors, and heirs represent and agree as follows:

I acknowledge that this athletic event or Activity is an extreme test of a person's physical and mental limits and carries with it the potential for death, serious injury and property loss. The risks include, but are not limited to, those caused by terrain, facilities, temperature, weather, condition of athletes, equipment, vehicular traffic, actions of other people including, but not limited to, participants, volunteers, spectators, coaches, event officials, and event monitors, and/or producers of the event, and lack of hydration. These risks are not only inherent to athletics, but are also present for volunteers. I hereby assume all of the risks of participating &/or volunteering in this event. I realize that liability may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained or controlled by them or because of their possible liability without fault.

I certify that I am physically fit, have sufficiently trained for participation in the event and have not been advised otherwise by a qualified medical person. I further acknowledge that the Activity will be conducted over public roads and facilities open to the public during the Activity and upon which the hazards of traveling are to be expected. If at any time I believe conditions to be unsafe I will immediately discontinue further participation in the activity.

I acknowledge that this Accident Waiver and Release of Liability (AWRL) form will be used by the event holders, sponsors and organizers, in which I may participate and that it will govern my actions and responsibilities at said events.

In consideration of my application and permitting me to participate in this event, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows:

(A) Waive, Release and Discharge from any and all liability for my death, disability, personal injury, property damage, property theft or actions of any kind which may hereafter accrue to me or my traveling to and from this event, THE FOLLOWING ENTITIES OR PERSONS: SALT LAKE RANDONNEURS, Richard Stum or RANDONNEURS USA, (RUSA), their directors, officers, employees, volunteers, representatives, and agents, the event holders, event, sponsors, event directors, event volunteers;

(B) Indemnify and Hold Harmless the entities or persons mentioned in this paragraph from any and all liabilities or claims made by other individuals or entitles as a result of any of my actions during this event.

I hereby consent to receive medical treatment which may be deemed advisable in the event of injury, accident and or illness during this event.

I understand that at this event or related activities, I may be photographed. I agree to allow my photo, video or film likeness to be used for any legitimate purpose by the event holders, producers, sponsors, organizers and or assigns.

This AWRL shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.

I hereby certify that I have read this document; and, I understand it's content. I understand that I have given up substantial rights by signing this AWRL and have signed it freely and without any inducement or assurance of any nature.
